 - c. Annual Meeting logistics (March 18 at 2 p.m. in the park):
 - i. Linda Ross will be in charge of ballot counting.
 - ii. Secretary Colbert will explore the possibility of a prize drawing for homeowners returning ballots.
 - iii. Heather McLellan will set up a table for the Auxiliary. The Auxiliary will provide food for the meeting.
 - iv. Director Prombo will set up the sign-in table for attendees.
